

Privacy Policy

The responsible handling of personal data is of great concern to the Friends of Mubaya Ecovillage Zimbabwe (hereinafter: Friends). The Association complies with the Swiss Federal Data Protection Act ([DSG](#)). In the following, the Association provides transparent and truthful information about the collection and use of personal data. Any changes will be communicated here immediately.

General: Personal data

In order for our offers to be targeted, relevant and used efficiently, it is necessary to collect certain data. People who are interested in the activities of the Friends, subscribe to a newsletter, or support the Association financially provide us with personal data. This data is compared with the existing address database and stored electronically. It is used exclusively for the purposes of the Friends. In order to maintain contact, it may be necessary to pass on extracts of this data to a voluntary service provider commissioned by us (e.g. webmaster). These service providers are subject to the Data Protection Act and, according to the agreement, may neither use the data for other purposes nor pass it on. Apart from this, no personal data will be given or marketed to third parties by the Friends.

Mailing

Anyone who provides us with a postal address can be informed about current topics by post at regular intervals, unless this is expressly not desired.

Electronic dispatch: e-mails and newsletters

Anyone who provides us with an e-mail address can receive information (such as payment confirmations, event notices) by e-mail. However, the regular sending of information, in particular newsletters, only takes place with the additional consent of the interested person (opt-in). Anyone who no longer wishes to receive our newsletter can easily and quickly unsubscribe by e-mail.

The Friends uses [Infomaniak](#), a hosting provider based in Lausanne, to send email newsletters.
